# Plat Vacation

---

The Applicant shall submit a Plat Vacation application to the Planning and Development Services Department (PDS) for approval by the Planning & Development Services Director as permitted and in compliance with Section 212.013 of the Texas Local Government Code, as amended. The purpose of a Plat Vacation is to nullify a portion of or the entire previously recorded plat.

## Plat Vacation Application Requirements

---

- **Please note that Plat Vacation Applications must be submitted via the [Round Rock Permit Portal](#).** Applications submitted in person are NOT accepted.
- **Please note that the Plat Vacation application will NOT be considered complete or filed unless all the application requirements are met.**

The Applicant shall upload all required documentation in .pdf format via the [Round Rock Permit Portal](#) unless otherwise noted:

1. Completed Project Application (complete form via [Round Rock Permit Portal](#)).
2. A letter from the Applicant to the PDS Director explaining the reason for the vacation.
3. Property deed(s), which identifies the owner(s) of the property. If Applicant is not the owner, then a letter granting the owner's permission to apply for the vacation is required.
4. An Abstractor's Certificate/Ownership and Lien Certificate which shall state the names and addresses of all current owners and lien holders of the property described in the vacating document. The Abstractor's Certificate/Ownership and Lien Certificate shall be dated no earlier than thirty (30) days prior to the submission of the plat vacation application.
5. Completed, signed and acknowledged plat vacation request(s) and approval(s) from all utility providers and the signature of the PDS Engineering Manager if public rights-of-way or easements are being vacated and the signatures of any additional entities authorized to use the easement (see "Forms" section).
6. Recorded plat to be vacated in .pdf format.
7. Payment of fees: In accordance with the fee schedule adopted by City Council. (See the Reference section of this packet for details). Fees for Plat Vacations can be paid via the online portal after the application has been accepted by PDS Staff.

Application Fee (base fee)	\$ 500.00
Legal Fee	\$ 100.00

### PLEASE NOTE:

A vacation of plat is not guaranteed. If one of the utility providers refuses to grant the vacation, then you may, at your own expense, attempt to negotiate with the utility company.
